#### Receptions in Hoffman Hall with Alcohol

Events that involve alcoholic beverages require up to 8 weeks for approval. The event form signor must be older than 21 years subject to request of proof. Approval will be based upon review and acceptance by the Executive Council. Alcoholic beverages include wine, beer and distilled grain alcohol. Any event where alcohol will be present requires the event signor to read and sign the Alcohol Responsibility Statement to be submitted with the Event Request Form.

Members of Christ Church requesting alcohol to be at an event will not be required to have servers. If servers are used, the company providing the servers will need to provide a liability waiver naming Christ Church as an additional insured.

Non-members of Christ Church requesting alcohol to be at an event will be required to use servers. The company providing the servers must submit a liability waiver naming Christ Church as an additional insured.

Alcoholic beverages may be brought on the premises and consumed within Hoffman Hall under the following conditions:

- The church will not provide beverages other than tap water.
- Alcoholic beverages cannot be served except by licensed and insured companies.
- Alcoholic beverages must be served only to people legally allowed to consume alcohol. In the state of Kentucky the legal age is 21 years or older.
- All alcoholic beverages must be removed from the church upon conclusion of the event.
  The event form signor must submit the Alcohol Responsibility sheet with the Event Form Request.

#### **Alcohol Responsibilities**

Beer, Wine and Distilled Spirits are drugs that can drastically impair a person's physical reactions and mental stability. Even legal consumption can result in dangerous situations.

Christ Church understands that consumption of alcohol can be a minor part of celebrating life events. We want to support events promoting celebration of life, not celebration of alcohol. The event should not exist as a reason to drink alcohol.

As the signor of the event form, you are stating to Christ Church that alcohol is a minor part of your event. If this is determined not to be the case, any deposits will be forfeited and fees may be imposed.

The legal age for alcohol in the state of Kentucky is 21. If your event will have people under that age attending, Christ Church requests that you discuss with them that any consumption, however obtained, of alcohol is illegal and they risk possible arrest. As the event form signor, you may be arrested also for providing alcohol to minors.

As the Event Form Signor, I understand my responsibility during this event to prevent alcohol abuse and illegal consumption.

Thomas Avenue, Ft. Thomas, KY 41075.

It is expressly understood and agreed that this release is intended to cover and does cover not only all now known injuries, losses and damages but any future injuries, losses and damages not now known or anticipated but which may later develop or be discovered, including all the effects and consequences thereof arising from the lease/rental of the Christ Church United Church of Christ premises.

And I/We hereby declare that I/We fully understand the terms of this Release.
